

API Security License

This API Security License (the “License”) is between You and Akamai Technologies, Inc. (“Akamai”) and governs Your use of the Akamai API Security Product . Akamai is willing to provide access to the Akamai API Security Product on the condition that You accept the License below. By accessing or using the Product and the Services (as defined below), You have indicated that You understand this License and that You accept all the terms contained herein. If You are accepting the terms of this License on behalf of a company or other legal entity, You represent and warrant that You have the authority to bind that company or other legal entity to the terms of this License, and in such event, “You” and “Your” will refer to that company or other legal entity. You and Akamai may be referred to herein collectively as the “Parties” or each individually as a “Party.”

1. Definitions.

- (a) “API(s)” means web (HTTP-based) Application Programming Interface(s).
- (b) “Akamai APIs” means the Akamai technology that performs API Security product functionality exposed to You via API.
- (b) “Customer Materials” means all proprietary information, data, and other materials, that is inputted, submitted, collected, transmitted or otherwise accessed by You through Your own systems or third-party systems related to Your business, products or services, in conjunction with Your use of the Product.
- (c) “Order Form” means the quote, order form or other document setting forth the Services being purchased from Akamai and executed by the parties
- (d) “Product” means a customer-specific instance of Akamai’s technology and related services that perform API security and analytics accessible via the Site and the Akamai APIs, including without limitation, the Neosec and Noname Security components of the Akamai ecosystem.
- (e) “Person” means any individual, corporation, partnership, trust, limited liability company, association, governmental authority or other entity.
- (f) “Site” means Akamai’s website from which the Product is made available to customers, including You, accessible at neosec.com, nonamesecurity.com, and/or akamai.com.
- (g) “Services” means collectively, the Product, the Site and the Akamai APIs.

2. Access and Use of the Services.

- (a) Provision of Access. Subject to Your compliance with the terms and conditions of this License, including the restrictions set forth in Section 2(b), Akamai hereby grants to You a limited, worldwide, non-exclusive, non-transferable (subject to Your Akamai Order Form) non-sublicensable right to use, access or operate the Product for Your internal business purposes.
- (b) Use Restrictions. You will not use the Product in any manner beyond the scope of the rights expressly granted in this License. You will not at any time, directly or indirectly, and will not permit any Person to: (i) modify or create derivative works of the Product, in whole or in part; (ii) reverse engineer, disassemble, decompile, decode or otherwise attempt to derive or gain improper access to any software component of the Product, in whole or in part; (iii) sell, resell, rent or lease use of the Product to any other Person, or otherwise allow any Person to use the Product for any purpose other than for Your benefit in accordance with this License; (iv) use the Product to store, transmit, upload or post any infringing, libelous or otherwise unlawful or tortious material or any data for which You do not have the necessary consents or rights to store, transmit, upload or post (as applicable) in connection with the Product; (v) interfere with, or disrupt the integrity or performance of, the Product, or any data or content contained therein or transmitted thereby; (vi) access or search the Product (or download any data or content contained therein or transmitted thereby) through the use of any engine, software, tool, agent, device or mechanism (including spiders, robots, crawlers or any other similar data mining tools) other than software or Product features provided by Akamai for use expressly for such purposes; or (vii) use the Product or any other Confidential Information (as defined below) of Akamai for any commercial or competitive purposes, including to create any product or service that competes with, or is designed to compete with, any of Akamai’s products or services.

(c) Authorized Users. Subject to the restrictions set forth herein, You may grant access to the Services to Your employees and independent contractors, who may only access and use the Services for the sole purpose of performing their job functions or services (as applicable) for You (“Authorized Users”). You acknowledge and agree that Your Authorized Users’ use of the Services is subject to this License, and that You are directly responsible to Akamai for ensuring that Your Authorized Users agree to, and comply with, this License and our Privacy Policy (as defined below).

(d) Account Registration and Access. If You or Your Authorized Users want to use the Services, You will have to create an account (“Account”). You can do this via the Site through our online registration procedures which we may update from time to time. It is important that You and Your Authorized Users provide us with accurate, complete and up-to-date information for Your Account and You agree to update such information to keep it accurate, complete and up-to-date. If You or Your Authorized Users don’t, we might have to suspend or terminate Your or their Account. You agree that You won’t permit any Person other than Your Authorized Users to access, use or operate the Product. You will use all reasonable means to secure user names and passwords, hardware and software used to access the Product in accordance with customary security protocols, and will promptly notify Akamai if You know or reasonably suspect that any user name and password has been compromised. You are responsible for all activities that occur under Your or Your Authorized Users’ Accounts, whether or not You know about them. You represent that You have not and will not misrepresent Your identity or otherwise provide any deceptive or misleading profile information or image in the creation of Your account with Akamai to use the Product.

(e) Updates. Akamai may from time to time develop patches, bug fixes, updates, upgrades and other modifications to the Product and may, in its discretion, make them available to You (collectively, “Updates”). You hereby acknowledge that such Updates may be required to use certain features or components of the Product, and You hereby agree (i) that You will promptly install any Updates that Akamai requires or makes available; and (ii) to the automatic installation of the Updates if performed by or on behalf of Akamai.

(f) Reservation of Rights. Nothing in this License or the performance thereof will operate to grant You any right, title or interest, whether by implication, estoppel or otherwise, in or to the Product or any other products or services offered by Akamai (or any intellectual property rights in the foregoing), other than as expressly set forth in this License. As between the Parties, Akamai will exclusively own all right, title and interest in and to the Services (including, without limitation, the Product), and any and all improvements, enhancement, modifications or derivative works to the foregoing (and all intellectual property rights in any of the foregoing). All intellectual property rights and related rights created in any such improvements, enhancements, modifications and derivative works will vest solely in Akamai upon creation, and to the extent that sole ownership does not originally vest in Akamai, You hereby automatically and irrevocably assign, and agree to irrevocably assign to Akamai, any and all such intellectual property rights. You shall take any and all actions and execute any and all documents necessary to give effect to the preceding sentence.

3. Proprietary Rights

(a) As between You and Akamai, except as set forth in this section, You will own and retain all right, title and interest in and to all Customer Materials. You hereby grant Akamai a non-exclusive, worldwide, royalty-free right and license to use, host, reproduce, display, perform, and modify the Customer Materials in connection with the hosting, operation, improvement and provision of the Product or any other business purpose during the Term.

(b) You may provide Akamai with suggestions, comments and feedback with regard to the Product (collectively, “Feedback”). You hereby grant Akamai a perpetual, irrevocable, royalty-free and fully paid-up license to use and exploit all Feedback in connection with Akamai’s business purposes, including, without limitation, the testing, development, maintenance and improvement of the Product.

(c) Nothing in this Agreement shall restrict Akamai (including any of its employees, representatives, or contractors) from using general ideas, concepts, practices, learning, or know-how obtained in the course of performing the services contemplated hereunder, that are retained in the unaided memory of Akamai (including any of its employees, representatives, or contractors) following performance of such services.

4. Additional Terms

(a) This License is subject to the Akamai [Terms & Conditions](#) (“GTC”), [Terms of Use](#) (“TOU”), [Acceptable Use Policy](#) (“AUP”), [Privacy Statement](#), and the applicable Order Form. In the event of a conflict of terms, interpretation, and/or construction of the GTC, TOU, AUP, Privacy Statement, Order Form, and this License, the controlling priority of the documents will be in the following order (in decreasing priority): GTC, TOU, AUP, Privacy Statement, Order Form, and this License.
